January 2012

At WWIN, we have the privilege of meeting each grant recipient in person. When a woman comes in to receive her grant from WWIN, we share with her Julia's story, which is really WWIN's story. Grantees are often inspired to give back, to 'pay it forward', and to pass along the good that they have received from WWIN. In the 2010-2011 fiscal year, WWIN provided 233 grants to low income women totaling nearly \$760,000.

EDUCATION GRANT

"I have reached a major life goal of mine which is so rewarding! I am a charge nurse at a nursing rehab facility. I am also making a better living so that makes life less stressful." Sally continues to look forward after receiving her ED grant. She plans to pursue a Master's Degree in her future so that she can teach nursing. She writes, "Thank you for helping me to reach my goal of becoming a nurse!"

This grant covers the cost of books and tuition for up to 2 years, up to \$5,000 each year. WWIN clients often are returning to school after many years away, are working as they go to school, or raising a family, are seeking education to break into a new field, or a combination of all of these. Some of these non traditional education clients were homemakers for years and have recently found themselves with no marketable job skills. They show tremendous courage when they seek help to get the education to help fulfill their dreams and provide for themselves and their families.

PHYSICAL, DENTAL, VISION AND HEARING (PDVH GRANT)

Jane had begun to adopt a closed-mouth smile which she experienced as "TOTALLY UNNATURAL." "I became slow to laugh, and my social anxiety disorder roared into action. Mere conversation was a trying event, always trying to cover my teeth." Then a simple trip to the dentist, funded by a stranger through WWIN, changed her life forever, "I am so grateful for your kindness. What a gift!"

WWIN's most sought-after grant is the PDVH grant, as there is very little comprehensive low-cost dental support available to women in Washington State. This six-month grant provides up to \$3,000 for approved medical services including comprehensive restorative dental and basic vision, hearing, and physical screening exams. This grant also provides partial coverage for glasses or hearing aids.

When a woman's teeth are in poor shape it affects many aspects of her life. It may be difficult to eat and sleep due to pain, and she may feel physically ill or be malnourished. Women often find employers unwilling to hire them. They may suffer from poor self-esteem and experience depression and isolation. We frequently hear how repairing a woman's smile also repairs her health, her energy level, and her self-esteem.

In the 2010-2011 fiscal year, WWIN provided 71 women with this grant.

HEALTH INSURANCE PREMIUMS (IP GRANT)

Sara struggled with anorexia and had a myriad of other health issues. She was unable to work during her recovery and after receiving her grant she is looking forward to getting back into the work force. "I had to fight for my life and couldn't have done it without the WWIN grant." "I look forward to giving back to my community..." "Thanks to all of you at WWIN, I have defied the odds."

In 2010-2011, WWIN helped 11 women pay for their insurance premiums plus co-pays and deductible expenses.

WWIN will pay up to \$5,000 in health insurance premiums, co-pays, co-insurance, and deductible expenses for women who receive the Health Insurance Premium Grant.

Though our Insurance Premium grant is our smallest grant area, it's one where we see our funding may have a life-saving impact. Many of the women who seek out this grant were forced to leave jobs due to a serious illness that requires on-going treatment and are able to continue treatment with assistance from the WWIN grant.

COUNSELING GRANT

Debbie has been sober for two years and before she received the WWIN Counseling Assistance Grant she relapsed every year. She had never been able to grieve her father's death properly and struggled with coping with stressful situations. "I feel like a completely different person than when I started therapy..."

The WWIN Counseling Grant pays for up to 24 sessions of therapy within one year with a licensed therapist of the grantee's choice. Each grant recipient can decide how to utilize the 24 sessions, whether to attend weekly, twice monthly, or some combination thereof. She is also able to choose individual or group therapy.



In the 2010-2011 fiscal year, WWIN provided 87 low income women with these key counseling grants.
