We address a deep need in society, providing women a hand up to improve their futures, in turn, strengthening their families and our society as a whole. We give financial grants to low-income women in Washington State who are ready for transformational change in two grant categories: Health Care and Education. In fiscal year 2014 WWIN provided grants to 148 women and continued to fund 151 women who received a grant in the previous year. Payments were made to 157 providers throughout Washington. Health Care Grants ensure access to physical, dental, vision, hearing, and mental health care services. In FY14, WWIN funded 24 Physical, Dental, Vision, and Hearing Grants for up to \$3,000 each; 22 Counseling Grants for up to \$1,920 each; and 25 Health Care Gap Fund Grants for up to \$3,000 for specific services not covered by Apple Health (formerly Medicaid; implemented on January 1, 2014) and related provider access issues under Apple Health.

Education Grants remove a financial barrier to low-income students seeking higher education. Grantees receive a one-time grant that they may use for tuition, mandatory fees, books, or required supplies at the accredited Washington State College or university of their choice. In fiscal year 2014, WWIN funded 77 Education Grants for up to \$5,000 each.

- Since 1992 WWIN has provided over 5,700 grants to women in Washington State, providing significant financial support for higher education and health care needs
- 148 grants, ranging from \$200 to \$5,000, were awarded in our fiscal year 2014
- A survey of WWIN grantees from the last five years shows that:
 - 1 out of 3 raised their incomes enough to move themselves and their families out of poverty
 - Among Education grantees, 1 in 2 are now out of poverty
 - 3 out of 5 are now employed (a jump of 20% since the beginning of their grant periods)
 - Among Education grantees, 4 out of 5 are now employed
 - Upon completion of their grant cycle, 98% reported that their WWIN grant improved the quality of their lives
